- I. Call to Order: The meeting was called to order at 11:30 a.m.
- II. Consent Agenda: A motion to approve the Consent Agenda was made, seconded and approved unanimously.
- III. Public Comment: Hong Guo informed senate of the Fall Open Educational Resources Regional Meeting—South. Deadline to register is September 11, 2017 at noon. There is no cost to attend, however registration is required.
- IV. Officer Reports

    3. Academic Mutual Agreement Council
      - a) AMAC met on May 22 and discussed the following:
        - (1) Dual Enrollment MOUs: The schedule and MOUs for three proposed dual enrollment sites in 2017-18 were shared. Several questions were posed regarding the schedule, and numerous inconsistencies were noted in the MOUs. Jeff and Marty met with Joumana McGowan to go over the agreements in more detail and work on changes. That work occurred prior to the end of the semester, and the changes were standardized.
        - (2) AP 4232 Pass or No Pass Grading: The AP was accepted as adopted by the Senate.
        - (3) Resolution 17-05 Encouraging the Use of Early Progress Reports: The resolution was discussed and accepted. Discussion focused on how we follow up on referrals once a faculty member makes them. It was agreed that more work needs to be done to improve the early progress system. Marty and Irene agreed to develop a draft communication to faculty consistent with the resolution. Deans and chairs will also be asked to mention the reports in their meetings on Flex Day.
        - (4) Resolution 17-06 Testing Center Facilities: The resolution was discussed and accepted.
        - (5) Faculty Hiring: New one-year temp requests from Communication and Paralegal were received.

- b) AMAC met on June 12 and:
- (1) Accepted the Faculty Coordinator Task Force Recommendations.
  - (2) Accepted the proposed BP 5010 and AP 5011, DEMAC proposal, the Senate's Dual Enrollment Task Force Recommendations and Resolution 17-09 in favor of AB 288 partnerships and forwarded those to Cabinet.
  - (3) Postponed discussion of Resolution 2017-08 Faculty Role in Commencement Planning.
  - (4) Accepted Resolution 17-10 Alternative Math Pathways.
  - (5) Accepted the Faculty Coordinator Task Force Recommendations.
  - (6) Accepted the appointment of Melinda Bowen to the LGBT Coordinator position in the PRIDE Center.
- c) AMAC met on July 6 and:
- (1) Approved one-year temp hires in Paralegal Studies and Communications.
  - (2) Accepted the Social/Ethnic Justice Studies Task Force recommendations (nos. 1, 4 and 5) previously passed by the Senate at the end of Spring.
  - (3) Accepted an explanation from the Director of DSPS on Resolution 2017-06 on the need for additional testing facilities, solving the concerns addressed in the resolution.
  - (4) Requested further information on the scheduling of lab courses regarding Resolution 17-07 Addressing Science Lab Space. Possible solutions might include Friday and Saturday labs as well as borrowing the space from iPoly in the afternoons after students leave.
  - (5) Accepted the 2017-18 Basic Skills Budget Recommendations with a request from the VPI that future recommendations be reviewed by her prior to going to committee.
- d) AMAC met on July 24 and:
- (1) Discussed a proposal from SOC/PHIL to separate the department into two departments. AMAC requested that the department follow AP 3110 and then resubmit the proposal once classes resume.
  - (2) Discussed minor changes to AP 7120 Faculty Hiring to address situations where the funding source for hires comes from categorical or restricted sources. The revisions will allow both the Senate and the Instruction Team to exempt such positions from prioritization if they do not impact the FON, the stability of funding is safe, and there are no other impacts to the college budget. If these factors mitigate against exempting the positions from prioritization, they would still be vetted as all other positions.
  - (3) Made minor revisions to the Request to Fill form based on changes in AP 7210.
  - (4) Accepted Resolution 2017-03 Senate Oversight of Program Development. Going forward, Senate leadership will ask to see any plans/grant proposals/letters of intent/etc. that relate to curriculum. The process will also entail Administration and Instruction sharing such opportunities with the Curriculum Liaison so that C&I can properly oversee the development of such programming with the goals of having Senate oversight into the development of the curriculum and further speeding the approval of time-sensitive curricular and grant needs.
  - (5) Accepted Resolution 2017-08 Faculty Role in Commencement Planning.
- e) AMAC met on Aug. 17 and:
- (1) Received an update on the status of AB 705 (Irwin) (Use of multiple measures) and discussions within MATH and ENGL on the appropriateness of using such metrics for placement in ENGL and MATH courses.
  - (2) Started discussion of the possibility of providing a general work experience program to students. Senate leadership agreed to take the idea to the Senate Planning Retreat scheduled for Aug. 24 to discuss and consider formation of a work group or task force to provide recommendations on whether and how to move forward.
  - (3) Clarified the work of Senate coordinator expectancies for work between intersessions and primary semesters.
  - (4) Discussed the possibility of reviving a task force to examine issues related to textbooks and exclusivity given to off-campus bookstores by professors, OERs, and other issues associated with management of the bookstore.

    - a) The committee did not meet over the summer.

    - a) The committee did not meet over the summer.
  7. Institutional Effectiveness Committee
    - a) The committee did not meet over the summer.
  8. President's Advisory Council
    - a) PAC met on June 14 and:
      - (1) Received an update from the Budget, Information Technology Advisory, Professional Development Council, Institutional Effectiveness and Accreditation Steering committees.
      - (2) Made minor changes to the Purpose and Function Statement of the VOICES Committee and approved the Purpose and Function Statement for the Dual Enrollment Mutual Agreement Committee ("DEMAG").
      - (3) Revised the Annual Planning Memo to go to committees to promote goal-setting in the Fall with progress reported at the end of the year.
      - (4) Approved BP 7601 – Campus Public Safety Internal Policies and Procedures with minor revisions.
    - b) PAC met on June 28 and:
      - (1) Approved minor changes to the Purpose and Function statement for the HBR Committee.
      - (2) Approved AP 4232 – Pass/No-Pass Grading.
      - (3) Approved BP 5010 – Admissions and AP 5011 – Admission and Concurrent Enrollment of High School Students and Other Young Students.
      - (4) Accepted minor changes to BP/AP 6510 – Networked Video Cameras on the first reading.
    - c) PAC met on July 12 but did not have a quorum. PAC received an update on accreditation, which included a seven-year approval, a request that SLOs be published on syllabi and other suggestions. PAC also received an update from the Facility Advisory Committee.
    - d) PAC did not meet on July 26 due to the President being out of town.
    - e) PAC met briefly on August 9 for a first reading of AP 7121 – Recruitment and Hiring: Classified Employees.
    - f) PAC did not meet on Aug. 23. The next meeting is scheduled for September 13.
  9. Board of Trustees' Meetings
    - a) The Board of Trustees met June 28. At that meeting:
      - (1) Four Dual Enrollment MOUs were approved by the Board, 3 being non-AB 288 agreements and the other an AB-288 agreement. The three non-AB 288 agreements are with iPoly, Rowland Heights USD, and West Covina USD. The AB 288 agreement is with Pomona Unified.
      - (2) The 2017-18 Tentative Budget was presented and approved. The college is expecting to receive approximately \$3.8 million from its work with Guided Pathways (one-time) and a \$4.6 million dollar increase to the Base Allocation. This is prior to paying increases for CalSTRS and CalPERS, etc. The 2017-18 projecting ongoing budget deficit is roundly \$1.1 million. A challenge the college is project to face is reduced growth funds. The college will go into stabilization this year, along with about ½ of the districts around the state.
    - b) The Board of Trustees met July 12 and:
      - (1) Received a presentation on the Physical Education Project Update.
      - (2) Approved the AB-288 CCAP agreement with Pomona USD.
  10. The Board of Trustees met August 9 and:
    - (1) Approved a Supplemental Environmental Impact Report, giving the green light to continue work on certain Physical Education Projects.
    - (2) Discussed several BP 5010 – Admissions, as it relates to Dual Enrollment offerings, and BP 7602 – Police and Campus Safety Department Internal Policies and Procedures.
    - (3) The Board received as informational items changes to AP 4243 – Pass/No-Pass Grading and Revisions to AP 5011 – Admission and Concurrent Enrollment of High School and Other Young Students.
  11. Management Screening Committee Appointments

a) Only one management hiring committee met over the summer, requiring a call for faculty volunteers. Two others were delayed by management until the fall – including the Associate Dean, Natural Sciences and the Manager, Farm positions.

B. Vice President:

1. Flex Day

a) Flex Day was this past Friday, August 25. There were 23 breakout presentations that were held over two sessions. Every attempt was made to coordinate with the President's office, POD, Event Services, and IT in order to make this Flex Day run as smooth as possible. The Flex Day Planning Task Force will be reviewing the evaluations and begin working on Spring Flex Day soon.

2. Student Preparation and Success Council

a) The Student Preparation & Success Council met July 26, 2017, and was set as an Integrated Planning Meeting. I was unable to attend. The Council has a draft of the Integrated Plan that is due to the Chancellor's Office by December 15, 2017.

b) The first meeting will be September 18, 2017.

3. Campus Equity and Diversity Committee

a) Human Resources is reviewing online training programs that will meet the standards required for all employees to be trained on topics of Title IX, Sexual Harassment, and Discrimination.

b) EEO trainings will be available through POD beginning in October and will be offered monthly throughout the academic year. The ideal situation is to have several people trained early to have EEO representatives available for all hiring committees.

c) CEDC has not met. The first meeting will be September 18, 2017.

V. Legislative Liaison Report:

1. Upcoming Legislation:

a) AB 705 (Irwin): The bill would require community college districts to utilize high school metrics when placing students (passed out of Senate Education and will go to Senate Appropriations).

b) AB 214 (Weber): The bill seeks to address reducing hunger and homelessness among college students (passed out of Senate Education and will go to Senate Human Services).

c) AB 17 (Holden): The bill would authorize provide free or reduced fare transit passes to low income students (passed out of Senate Transportation and Housing and will go to Senate Appropriations).

d) AB 19 (Santiago): The bill would waive enrollment fees for all first-time, full-time (12 units or more) students (passed out of Senate Education and will go to Senate Appropriations).

e) AB 21 (Kalra): Immigration law enforcement activity on campus. The bill would (1) prevent disclosure of citizenship or immigration status information unless required by federal law; (2) seek to ensure that campus leadership has verified the legal authority behind any immigration enforcement activity on campus before it takes place; (3) make immigration legal assistance referral information available to students upon request; and (4) guarantee that students impacted by federal immigration enforcement do not lose eligibility for enrollment, financial aid, or other benefits as a result (passed out of Senate Judiciary and will go to Senate Appropriations).

f) AB 204 (Medina): The bill would establish additional procedures to ensure California Community College (CCC) students who lose student fee waivers for failure to meet minimum academic and progress standards are not unfairly impacted (was referred to the Senate Appropriations suspense file).

1) MORE & BETTER CTE FORUMS

VII. Noncredit Liaison Report:

1) **LA Regional Noncredit CTE Readiness Project**

- a) School of Continuing Education (SCE) hosted the first meeting for the LA Regional Noncredit CTE Readiness project on July 11, 2017. The meeting was facilitated by L.E. Foisia (Basic Skills Professor). There were 23 people in attendance including credit and noncredit faculty as well as administrators from the participating colleges (Cerritos College, Compton College, Glendale College, LA City College, LA Harbor College, LA Mission College, LA Southwest College, Citrus College, Rio Hondo College, West LA College, and Mt. SAC).

2) **SCE Professional Learning Community (PLC) Group**

- a) Over the summer, SCE lead faculty started a PLC group in order to provide professional development opportunities for noncredit faculty (predominantly adjunct) to build community through engagement with fellow faculty from all departments in the division (ABE, ESL, Short Term Vocational, Education for Older Adults, and Adults with Disabilities). The first SCE PLC event was to invite a speaker on adult learners with disabilities.

3) **Learning Disabilities Symposium**

- a) SCE invited renown expert, Dr. Margaret Bauman, M.D., founder of The Autism Research Foundation (TARF), to share her expertise about strategies and interventions to help adult students with learning disabilities succeed. The event was held on July 20, 2017; more than 40 people including Mt. SAC noncredit faculty and K-12 faculty from the Mt. San Antonio Regional Adult Education Consortium participated in the event.

4) **SCE Noncredit Faculty Flex Day**

- a) SCE will hold its first division-wide Noncredit Flex Day on Friday, September 1, 2017, in coordination with POD. Noncredit faculty will participate in discussions about ILOs and SLOs led by SCE lead faculty and Emily Woolery

(Outcomes Committee Co-Chair). SCE counselors alongside student representatives will provide noncredit faculty with information about programs that are offered within the division. Also, Eric Kaljumägi (FA President) and Joan Sholars (FA Vice President) will provide noncredit faculty an overview of the Faculty Association.

VIII. Faculty Association Report:

A. Negotiations

1. The new contract is now in effect except for TA #12, which deals with deadline changes for banking leaves. This TA will go into effect in winter. Updated contracts will be available later this semester. The FA will host two additional workshops regarding these changes on **13 September** at 1 PM and on **14 September** at 9:30 AM.
  2. For 2018, the new contract requires most re-opener items to have bi-lateral support. While we will conduct a survey, it is likely that some items will have to wait to 2019 to be addressed.

1. The FA will undertake re-opener contract negotiations with a three person team beginning in January 2018. The Faculty Association is looking for one or two members to volunteer to shadow the negotiations process, to assist the negotiations team with their research, and to attend CCA or CTA negotiations training in February or July 2018.
