1. Cabinet reviewed and commented on the following information items:
  - Mt. SAC has been awarded the 2020 United States Olympic Team Trials in Track and Field. [See the Mt. SAC announcement](#) and the [USATF announcement](#). The selection was made by USA Track & Field ([link](#)) which is the national governing body for track and field, and, as such, is charged with selecting the host site for the Olympic Trials. The initial MOU between USATF and Mt. SAC is [attached](#). Our selection as the host site generated a great deal of media coverage ([attached links](#)).
  - The 2017-20 LA WIOA Regional Plan ([excerpt](#), [full plan](#)) and LACO Local Area Plan ([excerpt](#), [full plan](#)) include anticipate activities by these agencies in education and training with an emphasis on workforce credentials and career pathways for which Mt. SAC should be aware and involved.
  - The Accrediting Commission for Community and Junior Colleges (ACCJC) has announced ([see attached](#)) the appointment of Dr. Richard Winn as its next president.
  - At its June 7-9 meeting ACCJC formally approved ([see attached](#)) the full, seven-year accreditation of Mt. San Antonio College. Of the 14 community colleges reviewed last spring only three others received full accreditation: Deep Springs College ([link](#)), San Diego Mesa College, and San Diego Miramar College.
  - Vice Chancellor Pam Walker, who plans to retire shortly, has issued her final [CIO First Friday Newsletter](#).
    - Laura Hope is the incoming Executive Vice Chancellor for Educational Services ([see press release](#)).
    - The due date for the BSI/SEP/SSSP Integrated Plan for 2017-19 has been extended to December 15.
    - Using part of the Chancellor's Office generous 10% (\$20 M) set-aside from the Strong Workforce Program, a CTE Rebranding & Marketing campaign is set to launch.
    - Claremont Graduate University will offer its third summer Enrollment Management Academy for community college leaders led by our former colleague Pam Deegan, retired VP of Instruction at MiraCosta College.
    - California Community College Association of Occupational Education (CCCAOE) is facilitating More & Better CTE forums to educate CTE faculty and other local stakeholders about the resources available through the Strong Workforce Program. Next SoCal forum is August 25 at Moreno Valley College.

2. The California Public Employees' Retirement System (CalPERS) Board has approved its 2018 health plan rates. The [average](#) total PPO Basic Plan and PPO Medicare rates decreased by 2.50% and 2.04%. The [average](#) total HMO Basic Plan rates increased by 3.71% and the average total HMO Medicare Plan rates increased by 4.27%. See the [attached summary](#) for more information and links. Note that these are AVERAGES so Mt. SAC's rates—available later this year—could be up or down.
